USA-IWS CODE OF CONDUCT

I have familiarized myself with the spirit of the Code, and understand that acceptance of its provisions as written is a condition of my participation in a USA-IWS Event. My acceptance is given with my signature on the front.

To that end I Pledge to:

Act in a sportsmanlike manner consistent with the spirit of fair play and responsible conduct;

Act in a way that brings respect and honor to me, my team, the USA-IWS, and any USA-IWS sanctioned event;

Avoid criminal behavior;

Not use any medication or substance on the U.S. Olympic Committee ("USOC") neither banned substance list nor violate any procedures relating to use of banned substances;

Not use illegal substances nor violate procedures of the USOC and/or USA-IWS Anti-Doping Program

Refrain from conduct detracting from my peak performance or that of my teammate(s);

Refrain from the use of, or the providing of, alcohol or drugs in violation of local, state or national law;

Respect the property of others whether personal or public;

Respect members of my team, other teams, spectators and officials;

Avoid making disparaging remarks about said individuals, their decisions or calls;

Not engage in any form of verbal, physical or sexual harassment or abuse;

Follow my team's rules, including, by way of example, rules regarding curfew, required attendance at team meetings or functions;

Follow other such rules as may be in force during my attendance at a USA-IWS Event;
